The Committee held a minute's silence in memory of our colleague Róisín who died on 7 July.

1. APPROVAL OF AGENDA AND POTENTIAL CONFLICTS OF INTEREST

The Chairperson enquired and confirmed that there were no conflicts of interest in relation to any of the items of business before the Committee.

2. MINUTES OF MEETING OF 11 JUNE 2020

2.1 The Minutes of the PAEC Meeting held on 11 June 2020 were approved by the Committee.

3. MATTERS ARISING FROM THE MINUTES OF MEETING OF 11 JUNE 2020

3.1 A Named Provider

In September 2019, QQI validated two programmes of a named provider for one year. A special condition of validation was put in place which required the provider to review provision of the programmes after one year of provision and report back to the QQI Programmes and Awards Executive Committee (PAEC). The PAEC would then make a decision regarding the ongoing validation of the programmes beyond August 2020.

The provider submitted a draft Programme Delivery Review Report to the executive in June 2020. The provider suspended delivery of the programmes in March 2020 due to Covid-19. As a result, to date the provider has not concluded provision of either programme to any cohort of learners. The executive reviewed the report and concluded that a decision on the ongoing validation of the programmes could not be reached based on a review of

programme delivery to date. The executive has liaised with the provider and agreed that the review of the programmes will be postponed until autumn 2020 when it is anticipated that a number of learners will have completed at least one of the programmes and a substantial review of the programme can be concluded at that point. It is anticipated that this item will be tabled at the PAEC meeting in December 2020.

3.2 A Named Provider

In July 2019, QQI validated three programmes of a named provider for one year. Nine special conditions of validation were put in place when the programmes were validated, including one which required the provider to submit to QQI a report analysing the delivery of the programmes between September 2019 and June 2020, in a format agreed between the provider and QQI by mid-June 2020.

The provider submitted the report in mid-June as requested. Due to a QQI IT issue, the report was not received by the executive until mid-July and therefore was not processed in time for consideration at the July PAEC meeting. The executive will liaise with the provider on the report on delivery of the validated programmes over the coming weeks and requested the PAEC to delegate the decision on the ongoing validation of the provider's programmes to the executive.

The Committee APPROVED the delegation of the decision on the ongoing validation of the provider's programmes to the executive.

All other matters arising were covered within agenda items and were discussed during the meeting.

9. APPROVAL OF QUALITY ASSURANCE PROCEDURES FOR LEGACY PROVIDERS (RE-ENGAGEMENT)

9.1 Dorset College

11. CHANGE OF STATUS OF LEGACY HET AND FET PROVIDERS

11.1 The Committee NOTED the documentation circulated.

The Committee NOTED that 35 providers have been notified in writing that their continued status as relevant providers is under question due to:

- a. Voluntary withdrawal by provider
- b. Incorporation within the QA of an ETB

The Committee APPROVED the executive's recommendation to withdraw QA approval and programme validation from the providers in category a and b above. The executive will send a registered letter of notification to each provider.

12. REPORT FROM THE PROGRAMMES AND AWARDS OVERSIGHT COMMITTEE (PAOC)

12.1 Report from the Programmes and Awards Oversight Committee of 26 June 2020

The Committee NOTED the documentation circulated. At its meeting on 26 June 2020, the PAOC CONFIRMED the decision of the PAEC meeting of the 6 February 2020, to refuse validation of one programme of a named provider. The Committee NOTED the decision of the PAOC.

13. THEMATIC ANALYSIS OF PROVIDER REENGAGEMENT (QA APPROVAL)

13.1 Thematic Analysis of Provider Reengagement (QA Approval)

The Committee NOTED the documentation circulated. This paper informed the PAEC of the status and findings of the thematic analysis of reengagement commissioned by QQI in February 2020.

The analysis found that both providers and panel members reported the process to be a positive experience which has led to improvements in institutional QA. Panel members reported that the process was both implemented consistently and is fit-for-purpose.

Some recommendations for improvements to the process have also been identified, including:

- a. Use of a small number of Chairs and reports writers for multiple applications as a means of ensuring consistency of outcome;
- b. Production of a glossary of terms;
- c. Additional training for panel members;
- d. Allowance of more time for providers to respond at different stages of the process.

A number of these recommendations have already been taken onboard and are reflected in the management of current applications.

The Committee NOTED that the executive will finalise the report and prepare it for publication to the QQI website in July 2020.

14. INTENTION TO WITHDRAW VALIDATION OF PROGRAMMES

14.1 Intention to Withdraw Validation of Programmes

The Committee NOTED the documentation circulated. In May 2020, QQI contacted all FET providers other than the ETBs to seek clarification on the status of programmes validated for delivery by these providers. In each case, information was supplied to the providers regarding the certification history, or lack of it, for each programme. The providers were asked to identify programmes which they are satisfied can and should have their validation withdrawn as they have been validated for more than five years and are no longer on offer to learners. 63 providers identified 168 such programmes and these were listed in the documentation provided to the Committee.

The Committee APPROVED the withdrawal of validation of the FET programmes listed in the documentation.
